SUMMARY OF REQUEST FOR PROPOSAL (RFP) RFP # 18-040-57 LEACHATE HAULING MAR-OCO LANDFILL

On October 17th, 2018 Mar-Oco Landfill posted a request for proposal for the hauling of the leachate from the Mar-Oco Landfill to the City of Oconto Utility Commission Waste Water Treatment Plant. The table below summarizes the haulers who turned in proposals and their price per gallon for each year of the contract.

CITY OF OCONTO UTILITY COMMISSION 1210 MAIN STREET OCONTO, WI 54153

AGREEMENT

This Agreement in duplicate this 1st day of January 2019, by and between the City of Oconto Utility Commission, party of the first part hereinafter referred to as the "Commission", and the Marinette and Oconto County Landfill, party of the second part, hereinafter referred to as Mar-Oco.

WITNESSETH

- The Commission, in consideration of the Agreement contained herein, agrees to accept leachate from the Mar-Oco at the City of Oconto's WWTP.
- 2. The term of this Agreement shall commence on January 1, 2019 and shall terminate on December 31, 2019 unless extended by the Commission.
- 3. Upon request Mar-Oco agrees to provide to the Commission any analytical testing conducted on the Leachate.
- 4. MAR-OCO landfill shall pay to the Commission for amount dumped in the above sewage system according to the following schedule:

Leachate Treatment Charge - \$5.50 Per Thousand Gallons Dumping Charge \$5.00 Per Load

The above costs may be adjusted at any time by the Utility Commission during the term of this Agreement upon providing a minimum of Seven (7) days written notice to Mar-Oco.

- MAR-OCO Landfill shall pay amounts due to the Commission at 1210 Main Street, Oconto, WI 54153 within twenty (20) days of billing by the Commission. Interest at the rate of 1.5% per month shall accrue on all accounts not paid within the above period.
- 6. The Commission shall send the bill and any other notices to the MAR-OCO Landfill at 1926 Hall Ave, Marinette, WI 54143.
- 7. The Commission may refuse to accept the leachate from MAR-OCO Landfill at any time if they exceed D.N.R daily limits upon providing verbal notice to Mar-Oco's leachate hauler.
- 8. If MAR-OCO fails to comply with all the terms and conditions of this Agreement, the Commission may terminate this Agreement upon providing written notice.
- 9. This Agreement may not be amended or modified in any way accept in writing signed by both of the parties.
- 10. This Agreement together with attachments contains the entire Agreement between the Commission and Mar-Oco relating to the rights granted and the obligations assumed by the parties hereunder. Any prior agreements, promises, negotiations or representations, either oral or written, relating to the subject matter of this Agreement, not expressly set forth herein are of no force or effect.
