OCONTO COUNTY SANITARY PERMIT REQUIREMENTS

NEW CONSTRUCTION

Requirements for county approval are based on the type of septic system that the property is suitable to support. These were once referred to as perk tests but are now based on a **soil & site evaluation report** performed by a Certified Soil Tester (CSTM). Typically, three to six borings and/or backhoe pits are required to locate the initial system and replacement system. Once this area is delineated the report should be given to the installing plumber to prepare the plans and application for approval. All septic systems except conventional systems require state plan approval prior to submittal to the county. These systems are mounds, at-grade, holding tanks, and experimental systems. Also any system serving a public building requires state plan approval. The following are the steps required to obtain permits:

1. Parcel must be zoned properly;
2. If parcel is a split from another parcel then the new parcel # is required;
3. Applicant must be the owner of record;
4. Physical Address (fire number)
5. Maintenance Notice signed by owner to be aware of three-year maintenance requirement;
6. Sanitary Permit

REPLACEMENT SYSTEM

Requires at least three borings/backhoe pits and steps 3, 5, and 6 above. The county manages a state grant program for replacing failing septic systems built prior to July 1, 1978. Property owners must also qualify with other requirements prior to permit approval. Contact our office for further details. State funding for this program is subject to the state budget requirements.

RECONNECT TO EXISTING SYSTEM

In order to reconnect an existing system to a new or different dwelling the existing septic system must be evaluated for compliance with state codes. This typically requires pumping of the septic tank and an inspection by a certified plumber and a boring taken by a certified soil tester in the vicinity of the drainfield to confirm compliance with three-foot separation to any restriction. Fee is \$170 with county application form filled out by the inspecting plumber.

PRIVIES

Seasonal properties that intend not to have water service supplied to the structure are required to install a privy (outhouse). Requirements include a soil boring done by a CSTM to verify suitability of a pit privy (open bottom) or a vaulted privy (sealed container). Owner or plumber can file an application along with privy installation agreement signed by owner. This document needs to be recorded with the register of deeds. Steps 1 thru 6 apply. Fee is \$150 plus \$30 for recording this document.

GARAGE/SHED ONLY

If the property has no principal dwelling and the intention is to place a garage or shed on the premise, then a soil & site evaluation must be filed in our office to locate the proposed septic system on lots less than 5 acres. The intent is to set aside an area for future use so that the structure will not be located on possibly the only area for a septic system. No sanitary fee required.

The above information is intended for use of approval of a sanitary permit for the majority of situations that we have encountered. Typically this is a prerequisite for obtaining a land use permit. In most scenarios land use permits will follow the same procedure as shown in the above steps 1 thru 6. Please contact the office @ 920-834-6827 for fee information.
