4. Update on Law Enforcement Center

Project cost estimate now at \$30.5 million.

Bids for demolition are due today.
5. Jail Population Report

Current population – 72 inmates, 50% of which are sentenced inmates.
6. Demonstration of GPS/Bracelet System

Carol Kopp, Jail Administrator, provided a demonstration on how our system works. System includes a breathalyzer. We average about 3 to 4 per day on the system. The highest number on the system has been 8. Cost of the system is \$8/day per unit.
7. Discuss Pre-Trial Process

Starting in May, a revised intake day processing system will be tried.
8. Review of Assembly Bill

Joint Legislative Council submitted AB52 on February 17, 2015. Bill makes changes to the Criminal Justice Coordination Council system and the Treatment Alternatives and Diversion grant programs.
